- Fees will be constant for 2023-24 batch for three years and thereafter for M.B.B.S. and B.D.S. fees will be increased by 15% and 10% respectively for the said batch.
- Eligibility fees will be charged 5% on Tuition fees.
- Based on the demand for Post Graduate Courses, we may reduce the fees accordingly.

The Fee Structure in Medical and Dental Under Graduate and Post Graduate level Academic Programme fixed for the admission year 2023-24 will be valid for a period of next three years for the said batches. Then onwards, the fees for M.B.B.S. shall be increased by 15% (Fifteen Percent) and the fees for B. D. S. Course shall be increased by 10% (Ten Percent) of the existing fees for the remaining period of the Programme from the Academic Year 2026-27 (i.e. for the First year for BDS and First year for MBBS batch of 2023-24).
