The Pravara Institute of Medical Sciences (Deemed to be University), Loni vide its letter No.PIMS/RMC/DEAN/2022/7948/11 dated 3rd March, 2022 had applied for renewal of recognition of five seats (2 and 2 to 5) of MS (Orthopaedics) qualification in respect of students being trained at the Dr. Balasaheb Vikhe Patil Rural Medical College (formerly Rural Medical College, Loni), having an annual intake capacity of ten seats in the said course.

- 2. WHEREAS, the Post-Graduate Medical Education Board (PGMEB) got the assessment of the Dr. Balasaheb Vikhe Patil Rural Medical College (formerly Rural Medical College, Loni) done on 23rd February, 2023 for verification of infrastructure, clinical material, faculty for all-round training of students as per curriculum requirement. On scrutiny of the Assessment Report and other records, the Post-Graduate Medical Education Board (PGMEB) found the following deficiencies:
 - Clinical material was less than the required norms as bed occupancy was inadequate; and
- ii. Surgical load was also inadequate.
- 3. WHEREAS, the deficiencies stated in para 2 above were pointed out to the said medical college *vide* PGMEB Letter No.35/46(109)/2022-PGMEB/018998 dated 13th April, 2023 and the medical college was given an opportunity to submit a written explanation in respect of the deficiencies. The Pravara Institute of Medical Sciences, Loni furnished the reply *vide* Letter No.PIMS/DBVPRMC/DEAN/2023/865 dated 27th April, 2023. The Compliance Verification Report, furnished by the said medical college, was placed before the Post-Graduate Medical Education Board. The Board observed that the surgeries and clinical material (IP and OP) in the Department of Orthopaedics is inadequate for the annual intake of ten post-graduate seats (thirty-odd PG students studying at a given time). Hence, the reply furnished by the medical college was not found satisfactory and acceptable by the Board.
- WHEREAS, the responsibility of determination and maintenance of standards of post-graduate medical education is entrusted upon the Post-Graduate Medical Education Board of the National Medical Commission as per National Medical Commission Act, 2019 (NMC Act, 2019), Post-Graduate Medical Education Regulations-2000 (PGMER-2000) and Maintenance of Standards of Medical Education Regulations, 2023 (MSMER-2023). Further, Section 6.2 of the PGMER-2000 and Section 8(1) and (2) of the MSMER-2023, stipulate imposition of penalty(ies) on the medical college/institution, if they fail to comply with any statutory provisions.

WHEREAS the medical college has failed to comply with the requirements and has compromised with the quality of medical education. Considering the inadequate surgeries and low clinical material in the Department of Orthopaedics, which is not adequate for training the PG students studying in the medical college; the Post-Graduate Medical Education Board has decided to renew recognition of five seats (02; 2 to 5) of MS (Orthopaedics), but at the same time reduce the annual intake capacity in the course of MS (Orthopaedics) from the existing ten to eight seats from the Academic Year 2024-2025. Hence, the break-up of MS (Orthopaedics) seats in the medical college will be as indicated below:

* - The medical college will apply for renewal of Recognised Seats (Conversion Seats) [5 to 7] and Permitted Seats [7 to 8] as and when they become due for renewal.

However, the students admitted by the medical college till the Academic Year 2023-2024 will not be affected by this reduction of seats and their post-graduate degrees will be considered recognised for the purpose of registration of the degree awarded by the University.

- 6. The recognition so being granted herein, shall be valid for a maximum period of five (5) years from the date of issue, upon which it shall have to be renewed. The procedure for 'Renewal of Recognition' shall be same as applicable for the award of Recognition. Failure to seek timely renewal of recognition shall invariably result in stoppage of admissions to be concerned post-graduate course.
- 7. WHEREAS, the medical college is free to prefer an appeal before the National Medical Commission under Section 35(5) of the National Medical Commission Act, 2019 and Section 9 of Maintenance of Standards of Medical Education Regulations, 2023, within sixty days from the date of issuance of this letter in accordance with NMC letter No.C.16013/36/2022/NMC/Coord dated 28.12.2022 and 28.08.2023, if they so desire, at the email id nmc_appeal@nmc.org.in.


